II. TECHNICAL SPECIFICATIONS:

- Light weight bomber jacket
- Collar, sleeves and bottom hem finished with a ribbed decorative trim
- With side pockets
- With lining and inner pockets
- In Khaki color
- Material:

Collar-100% cotton

Main material - 75% cotton, 25% polyester

Lining: 100% polyester

- Imprint Method: embroidery
- Must have available unisex sizes in extra small (XS), small (S), medium (M), large (L), extra-large (XL), double extra-large (2XL), three extra-large (3XL), four extra-large (4XL), and five extra-large (5XL);
- Must follow the logo print, colors and dimensions using embroidery print type and must ensure that the embroidery will not be undone / become loose upon washing.

III. TERMS AND CONDITIONS:

- 1. Interested bidders must <u>submit a sample prototype of the material of jacket to be used</u> (i.e. to determine fabric-type and print method to be used) upon submission of their quotation, for evaluation purposes.
- 2. Winning bidder must submit sample jacket with all available sizes of the appropriate material.
- 3. Samples submitted shall be retained by the end-user until delivery of items for comparison.
- 4. Bid price must be firm and irrevocable and not subject to any change, whatsoever, even due to increase in cost of raw material and lack of supplies.
- 5. Deviations from the original offer will not be accepted.
- 6. Winning bidder must conform with the color and size of logo to be printed, including the color and jacket design.
- 7. Winning bidder must replace defective items within a week period upon complaint.
- 8. One hundred percent (100 %) of the contract price will be processed within 30 days upon the issuance of a certificate of acceptance of the end-user but not earlier than seven (7) working days upon issuance of said certificate.
- 9. Bid price must be in Philippine currency and must be inclusive of all costs like taxes.
- 10. Bidder must be able to deliver **70 pieces** of the said jacket conforming with the required colors and sizes as provided by the end-user.

11. Delivery Terms:

- a. Delivery of Sample/ Prototype 5 calendar days after receipt of the Purchase Order (PO).
- b. Approval of sample 1 day after receipt of delivered sample
- c. Full Delivery on or before 30 April 2025 or the winning bidder will be subjected to penalties as stipulated in the provisions of Small Value Procurement under RA 9184.
