Background

- Last November 2, 2021, the President Rodrigo Roa Duterte gave three (3) directives for the national government agencies, local government units, stakeholders and societies to ramp up the vaccination activities nationwide utilizing all available resources
- As of November 14, 2021, the Philippines has received a total of 123,258,340 doses of COVID-19 vaccines, either procured or donated.
- As of November 14, 2021 a total of 69,439,889 doses of COVID-19 vaccines have been administered nationwide. A total of approximately 53 million COVID-19 vaccine doses are still to be administered.
- Currently, the vaccination coverages of most Local Government Units have not reached at least 70% of the total population.
- Vaccinating as fast and as many will protect the population and will allow resumption of activities and open up the economy of the country.
- Achieving vaccination of at least 70% of the total population will require a whole-of society and a whole-of-government approach and the unified commitments of the national government, local government units, societies, international and local partners and organizations, the private sector, the health sector, and the communities.

Objective

- To mobilize all stakeholders, people and logistics to facilitate the vaccination with COVID-19 vaccines of at least 15 million individuals in three (3) days.

Roll-out Strategies for the National COVID-19 Vaccination Day

1. **Expand and activate vaccination sites**
 - a. **Activate all registered Vaccination Sites nationwide** Fixed Sites, Mega Vaccination Sites, Temporary Posts, Mobile Vaccination Teams
 - b. Use of schools/colleges/universities, arenas, gymnasiums, etc.
 - c. Reactivation/Activation of all hospitals as vaccination sites
 - d. Use of facilities of the private sector - fast food chains, malls, workplace
2. **Mobilize all government agencies, stakeholders and issue moratoriums at all levels (for government agencies)**
 - a. **All National Government Agencies:** DOH, NTF, DILG, AFP, PNP, BFP, BJMP, DepEd, CHED, DSWD, DOLE, PCOO, PIA, POPCOM and their regional counterparts
 - b. **All Local Government Units (LGUs):** Provinces, Municipalities, Cities to tap LGU resources and coordinate with private sector, religious and civil society groups
 - c. **Mobilize all societies (and provincial chapters), civil society organizations and private sector partners**
 - i. **Philippine Medical Association (PMA)** and their *component societies* (regions and provinces), *specialty societies* (esp Philippine College of Physicians, Philippine Pediatric Society, Philippine Academy of Family Physicians, etc), and *affiliate societies* (esp Association of Municipal Health Officers, etc); **Philippine Nurses Association (PNA), Integrated Midwives Association of the Philippines (IMAP), Philippine Pharmacists Association, Inc (PPhA), Philippine Dental Association (PDA)**, Private Sector partners, Philippine Red Cross, etc.
 - d. **Mobilize all healthcare workers in the Philippines and participate in the National COVID-19 Vaccination Day:** all public, private, and self-employed healthcare workers



Roll-out Strategies for the National COVID-19 Vaccination Day

3. Fast track delivery of vaccines and ancillaries

- a. Mobilize the assets of the AFP, PNP, OCD, DOTr and Private Sector in the delivery of vaccines and ancillaries
- b. Community-level logistics management thru local PNP/AFP and City/Municipal DRRMH with the Municipal/City Health Office as overseer

4. Intensify social preparation activities (drumbeat campaign)

- a. Dialogues through barangays assemblies, town hall meetings, FDS sessions
- b. Use of Social media and quad media
- c. Mobilization and feature of experts such as physicians, celebrities, civil societies
- d. House-to-house campaigns with bandillo
- e. Community leaders or influencers as advocates
- f. Deployment of social mobilizers and mobilization of barangay captains, tanods and BHWs
- g. Incentivize vaccine recipients vaccinated during the three-day period
- h. Utilize the “National Heroes Day” to emphasize Bayanihan spirit; infographics and poster making contest

5. Activate health emergency command system structure within LVOCs for governance and coordination



Operational Details for the National COVID-19 Vaccination Day

A. Governance:

1. **National Leads:** DOH-NTF and DILG
2. **Regional Leads:** RVOCs (DOH CHD)
3. **Local Leads:** LVOCs (LGU LCEs)
4. **Main Participating Entities:**
 - a. DSWD, DepEd, DOLE, DOT, DOTr, DOLE, DTI, CHED, TESDA, DND (AFP, OCD), DILG (PNP, BJMP, BFP), MMDA
 - b. PMA, PPS, PHA, PAFP, PCOM, PNA, PPA, PPhA, PDA, PPTA, IMAP, and other Medical and Allied health societies
 - c. Development Partners - World Health Organization and Unicef
 - d. Private Sector - T3, McDonalds, Jollibee, Ayala, SM, Robinsons, Megaworld
 - e. Religious and Faith-based Organizations and Civil Society Organizations - e.g. CBCP

- ❑ **Draft EO approved by IATF last November 18, 2021**
 - ❑ Ongoing clearance and for signature of approval of President Rodrigo Duterte
- ❑ Supporting policies and issuances (awaiting signed EO before release):
 - ❑ DOH Department Memorandum
 - ❑ DILG Memorandum Circular
 - ❑ DepEd Memorandum Circular



Mobilizing Health Human Resource

UPDATES:

- ❑ **Deployment of the National Vaccination Volunteer Registration on November 18, 2021 at 3PM**
 - ❑ **As of 7:45 AM today:** 11,490 volunteers
 - ❑ **Vaccination Team:** 2,920 volunteers
 - ❑ **Encoders:** 8,499 volunteers
- ❑ AFP to deploy **80 teams** as Vaccinators at Large (VVAL) to GIDA Areas.
- ❑ Release of **NVOC Advisory No. 102** entitled “Guidance in the Deployment of Medical, Nursing, and Allied Health Professionals, Teachers and Data Professionals as Volunteers for the National Vaccination Days”.

UPDATES:

- ☐ For volunteers, here are the steps in registering:
 - ☐ Register in this link: <https://tinyurl.com/3fxytrjm>, or this QR Code:
 - ☐ Fill-out the data fields in the NVVR. You are given the option to choose which LGU you are willing to be assigned to.
 - ☐ After submitting the completed form, await for the call or message of the LGU or Center for Health Development. Your information and contact details will be forwarded to the LGUs where you are willing to be assigned.
 - ☐ If after five (5) days or before November 22, you have not been contacted, kindly call the **DOH OpCen Hotline: (8) 711-1001 or (8) 711-1002**. The team shall facilitate coordination and link you to the appropriate point person.



Mobilizing Health Human Resource

UPDATES:

- ❑ **For Local Government Units, here are the steps in enlisting volunteers:**
 - ❑ Assign a point person who will facilitate and communicate with the volunteers.
 - ❑ Assign your data manager to download the list of volunteers with their contact details from the **Vaccination Operations Reporting System (VORS)**.
 - ❑ Contact the volunteer and provide instructions accordingly. If you have sufficient human resource for you to meet your daily targets, contact the DOH Center for Health Development point person. He/She will facilitate the re-assignment of the volunteer to areas where volunteers are most needed.



Mobilizing Health Human Resource

UPDATES:

- ❑ **For DOH Centers of Health Development, here are the steps in facilitating the assignments of volunteers:**
 - ❑ Assign a point person who shall monitor and facilitate the coordination between the LGU and the volunteer.
 - ❑ Monitor the number of volunteers in the region.
 - ❑ Ensure that all volunteers are timely contacted by the LGUs.
 - ❑ If the volunteer/s have not been contacted or the LGU already has sufficient number of human resource and volunteers, facilitate the re-assignment of the volunteers to areas where volunteers are most needed.



Mobilizing Health Human Resource

UPDATES:

- ❑ **For medical societies and other health-related organizations/societies (e.g. Philippine Medical Association, Philippine Pediatric Society, Philippine Hospital Association, Philippine Academy of Family Physicians, Philippine Pharmacists Association, Inc, Philippine College of Occupational Medicine, Philippine Pharmacist Association, Philippine Nursing Association, Philippine Dental Association, Philippine Physical Therapy Association, Inc, Integrated Midwives Association of the Philippines, among others) and religious organizations and civil societies:**
 - ❑ Ensure that all your members volunteering are registered in the NVVR. However, to facilitate ease in coordination with the LGU, your chapters may directly communicate with the point persons of the LGUs.
 - ❑ Coordinate and provide updates to the DOH CHD point person. Please ensure that you provide the contact details of your chapter's point persons to the DOH CHD.
 - ❑ For any concerns of your chapter, you may raise this to the LGU or DOH CHD.



Activating and Registering Vaccination Sites

UPDATES:

- ❑ No. of registered vaccination sites:
 - ❑ 8,505 registered vaccination sites
- ❑ DepEd to release a Memorandum Circular in the utilization of the schools as vaccination sites.



Logistics

UPDATES:

- ❑ Ongoing coordinative meetings per regions on the logistics preparations (using the forecasting tool)
- ❑ Ongoing regional coordination with other agencies concerned in the vaccine logistics
- ❑ Transport/Credo boxes for delivery to the regions % DOH



Data Management

UPDATES:

- ❑ **Ongoing cascading of the Mobile VAS for vaccination sites without internet connection**
- ❑ **Collaboration with the following agencies/societies for the encoders:**
 - ❑ **DILG - SK:** initial meeting; DILG to give directives to mobilize the SK as encoders and use of the barangay laptops in the vaccination sites.
 - ❑ **DepEd:** initial meeting; DepEd to release a memorandum circular to mobilize teachers as encoders
 - ❑ **JPIA and PICPA:** initial meetings conducted
 - ❑ **DOLE:** to deploy 2,000 encoders
