PDIC starts deposit insurance payments to depositors of the closed Opportunity Kauswagan Bank, Inc.

The Philippine Deposit Insurance Corporation (PDIC) announced that it started mailing Postal Money Orders (PMOs) on February 17, 2022 to all depositors eligible for outright payment who maintained deposits with the closed Opportunity Kauswagan Bank, Inc.

Eligible for outright payment of deposit insurance are individual depositors with valid deposit balances of P100,000 and below who have no outstanding loans with the closed bank, and have a complete mailing address in the bank records or updated this information through the PDIC Mailing Address Update Form (MAUF).

PMOs amounting to £15,000 and below may be encashed either with the local post office or with the nearest branch of the Land Bank of the Philippines. Meanwhile, PMOs above £15,000 may be deposited to the depositor's account in any local bank.

Depositors who have not received their checks after April 29, 2022 from their Local Post Office are advised to contact the Public Assistance Department during office hours at telephone number (02) 8841-4141, or e-mail PDIC at opportunity-pad@pdic.gov.ph. Depositors outside Metro Manila may call the PDIC Toll Free Hotline during office hours at 1-800-1-888-PDIC (7342). Opportunity Kauswagan Bank, Inc. was ordered closed by virtue of Monetary Board Resolution No. 1635.B dated December 2, 2021. It is a 23-unit microfinance rural bank with Head Office located at Unit 1, A& L Building, E. Lopez St., Brgy. San Vicente, Jaro District, Iloilo City. Its branches and branch lite units are located in Antique, Iloilo, Aklan, Guimaras, Capiz, Cebu, Bohol and Leyte.

The Philippine Deposit Insurance Corporation (PDIC) was established on June 22, 1963, by Republic Act 3591 to provide depositor protection and help maintain stability in the financial system by providing deposit insurance. Effective June 1, 2009, the maximum deposit insurance coverage is P500,000 per depositor. All deposit accounts by a depositor in a closed bank maintained in the same right and capacity shall be added together. A joint account shall be insured separately from any individually-owned deposit account.
