- 5. Based on the cost-benefit analysis conducted by the procuring unit, engagement of GSIS for the rental of its gymnasium is beneficial, practical and cost-effective.
- 6. As per Certification dated 21 November 2014, GSIS certifies that it is leasing out the GSIS gymnasium to the PDIC by virtue of the agencies' partnership on their financial literacy programs. It further certifies that its gymnasium has the necessary basic tools and equipment required for the holding of the PDIC PRAISE Awards.

WHEREAS, based on the foregoing facts and circumstances, the request for the procurement, through Agency-to-Agency Agreement, of the GSIS gymnasium as the venue for PDIC Praise Yearend Awards is deemed compliant with the Implementing Guidelines on Agency-to-Agency Agreement issued under GPPB Resolution No. 03-2011 dated January 28, 2011, as amended;
