RESOLUTION NO. 15-16

WHEREAS, the Philippine Deposit Insurance Corporation (PDIC), thru its Bids and Awards Committee (BAC), posted the Invitation to Bid for the re-bidding of the procurement of the services of a sports event organizer for the conduct of PDIC Wellness and Benefit Run in the PDIC website, Phil-GEPS website, and in a conspicuous place within the premises of PDIC, continuously for seven (7) calendar days;

WHEREAS, in response to said advertisements, two prospective bidders, namely: (i) Metro Advantage Media Marketing Services Co. (Metro Advantage) and (ii) Huper International, purchased the bidding documents. However, only Metro Advantage submitted the eligibility, technical and financial documents/proposals on or before the Opening of Bids on 20 March 2015;

WHEREAS, Metro Advantage passed the eligibility check and submitted a bid amount of Php1,000,000.00 as against the approved budget for the contract of Php1,100,000.00. As a result, Metro Advantage was considered as the bidder with the single calculated bid, subject to the detailed evaluation of its bid, and post-qualification;


WHEREAS, after careful examination, validation, and verification of all its eligibility, technical, and financial documents, Metro Advantage passed the criteria for post-qualification, and its bid has been found to be responsive;

NOW, THEREFORE, WE, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

1. To declare Metro Advantage Media Marketing Services Co. as the bidder with the Single Calculated and Responsive Bid for the procurement of the services of a sports event organizer for the conduct of PDIC Wellness and Benefit Run; and
2. To recommend the award of the contract for the procurement of the services of a sports event organizer for the conduct of PDIC Wellness and Benefit Run to Metro Advantage Media Marketing Services Co. for Php1,000,000.00.
