A. Amendments:

B. Clarifications/Reiterations:

- 1. Copies of the contracts listed in the Statement of All Ongoing and Completed Contracts within the period 2012-2014 (Bid Form No. 2) need not be attached. However, the BAC may require its submission during evaluation/post-qualification for reference/verification.
- 2. Bidders are requested to bring the original copies of the submitted bid documents for verification/reference, in case the submitted copies are not clear or readable.
- 3. Security guards in the Ayala and Chino Roces premises follow a duty shift of 2:00AM 2:00PM and 2:00PM 2:00AM. The night differential pay which covers the time of 10:00PM 6:00AM will therefore be applicable to AM/PM shifts.
- 4. The night differential pay shall be computed at 10% of the daily wage.
- 5. Security Guards Requirement: 68 (please see attached Matrix)
- In computing for the average pay per month per guard, bidders may use 310 days for six (6) days work and 258 for five (5) days work.
- 7. In computing the financial bid, the bidder shall round off its bid up to the hundredths place. (sample: P12.367 round up P12.37)
