

**PHILIPPINE DEPOSIT INSURANCE CORPORATION**  
**INVITATION TO BID FOR Procurement of Patch**  
**Management System for Philippine Deposit Insurance**  
**Corporation - Rebidding**

1. The *Philippine Deposit Insurance Corporation (PDIC)*, through the *2022 Corporate Operating Budget* intends to apply the sum of **Php 3,000,000.00** being the ABC to payments under the contract for *Procurement of Patch Management System (PMS) for PDIC (Rebidding) / Identification No 2022-26(R)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *PDIC* now invites bids for the above Procurement Project. *The PDIC needs to procure a PMS with a three (3) year maintenance subscription and support service necessary to minimize the exposure of PDIC to vulnerabilities brought about by outdated and unpatched operating system and third-party software/applications.* The Bidder must have completed a similar contract in providing the said maintenance services for the last five (5) years, reckoned from the date of the posting of the Invitation to Bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Prospective Bidders may obtain further information from *PDIC* and inspect the Bidding Documents at the address given below during *office hours from 8:00 AM to 5:00 PM, Mondays through Fridays.*

A complete set of Bidding Documents may be acquired by Bidders on August 2, 2022 from the address above and website(s) below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 5,000.00.* The Procuring Entity allows the bidder to present its proof of payment for the fees *in person.*

The *PDIC* will hold a Pre-Bid Conference<sup>1</sup> on August 16, 2022 at 2:00 PM at the *8<sup>th</sup> Floor, Board Room, SSS Building, Ayala Avenue corner Rufino Street, Makati City* and through video conferencing or webcasting via *MS Teams link herein below provided* which shall be open to prospective bidders:



7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 2:00 PM August 30, 2022 Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on August 30, 2022, 2:00 PM at the 8th Floor, Board Room, SSS Building, Ayala Avenue corner Rufino Street, Makati City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. Late bids shall not be accepted. The wall clock located at the Ground Floor lobby, SSS Building, Ayala Avenue corner Rufino Street, Makati City shall be used as the official timer for the submission of bids. Submission made after the deadline shall be considered late and automatically rejected.

The PDIC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
