### MEMORANDUM OF AGREEMENT

### KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (MOA), made and entered into, by and between:

V.A. Rufino Street, Makati City, represented herein by its President, Mr. VALENTIN A. ARANETA, and hereinafter referred to as "PDIC"

The PHILIPPINE POSTAL CORPORATION, a government-owned and controlled corporation created and existing by virtue of Republic Act No. 7354, with office address at Liwasang Bonifacio, Manila, represented herein by its Postmaster General and Chief Executive Officer, Ms. Ma. JOSEFINA M. DELA CRUZ, and hereinafter referred to as "PPC"

### WITNESSETH: That -

WHEREAS, PDIC is mandated under the law to provide depositor protection and strengthen public confidence in the Philippine banking system;

**WHEREAS, PDIC** believes that depositor education is a vital component of depositor protection, which in the end will redound to increased public confidence in the banking system;

**WHEREAS**, in line thereto, and in commemoration of its 50th anniversary, **PDIC** intends to issue, circulate and distribute commemorative stamps and other philatelic products designed to further promote deposit awareness to the general public, with the end in view of strengthening public confidence in the Philippine banking system;

**WHEREAS**, **PPC** similarly shares **PDIC's** vision and recognizes the importance of strengthening public confidence in the stability of the Philippine banking system;

WHEREAS, PPC, being the sole government entity tasked by law to produce, print, circulate and sell commemorative stamps and other philatelic products, has agreed to produce, print, circulate and sell PDIC commemorative stamps and other philatelic products, with the end in view of promoting deposit awareness; and thus, strengthen public confidence in the Philippine banking system.

**NOW, THEREFORE**, for apid in consideration of the foregoing premises, and the mutual covenants herein contained, the parties hereto hereby agree as follows:

## ARTICLE I SCOPE/COVERAGE

This MOA pertains to the development, production, printing, circulation and distribution of PDIC 50<sup>th</sup> anniversary commemorative stamps and other philatelic products, which are intended to promote deposit awareness to the general public. And thus, strengthen public confidence in the Philippine banking system.

## ARTICLE II RESPONSIBILITIES OF PPC

In pursuance of the objective of this MOA, **PPC** undertakes to do the following:

- 1. Assist **PDIC** in the development of the designs to be depicted in PDIC commemorative stamps and other philatelic products.
- 2. Undertake the printing, circulation and distribution of PDIC commemorative stamps and other philatelic products.
- 3. Deliver to **PDIC** the commemorative stamps and other philatelic products within the period and in such quantity as agreed upon by the parties.

# ARTICLE II RESPONSIBILITIES OF PDIC

PDIC, for its part, undertakes as follows:

- 1. Provide **PPC** with the designs to be depicted in PDIC commemorative stamps and other philatelic products.
- 2. Purchase from **PPC** the commemorative stamps and other philatelic products at such costs and quantity as shall be agreed upon by the parties.
- 3. Assist **PPC** in the circulation and distribution of PDIC commemorative stamps.

# ARTICLE IV SCHEDULE AND COSTS

The timetable and costs of this project shall be subject to the agreement of the parties as contained in Annex A hereof, which shall be deemed as integral part of this MOA. The parties shall strictly implement the project in accordance with the agreed timetable. Production-related and other similar activities shall commence immediately upon the initial transfer of funds by **PDIC** to **PPC**.

**PPC** shall submit written request to **PDIC** for any extension of the production or implementation period in cases of fortuitous events and/or intervening factors outside of **PPC's** control.

# ARTICLE V FINANCIAL AND BUDGETARY REQUIREMENTS

Upon the execution of this MOA, **PDIC** shall, at its option, pay in cash or by manager's check at least fifty percent (50%) of the value of PDIC commemorative stamps and other philatelic products agreed to be purchased by **PDIC** to **PPC**. Payment of the remaining fifty percent (50%) shall be made by **PDIC** upon **PPC's** delivery of PDIC commemorative stamps and other philatelic products in accordance with *Annex A* hereof.

Firther, the following shall apply:

- 1. Each and every payment herein required shall be made by **PDIC** no later than seven (7) working days from the date they become due. All payments shall be understood to include any and all taxes (including, but not limited to, the applicable Value Added Tax), fees, duties and such other imposts or levies which may be required by the government, both national and local.
- 2. All disbursements made under this MOA shall be subject to government accounting rules and regulations.
- 3. Additional services performed by **PPC** upon the request of **PDIC** which are not within the scope of this MOA shall be billed separately by **PPC**.

## ARTICLE VI CONDITIONS OF EFFECTIVITY

The obligations pertaining to the contracting parties shall remain in full force and effect regardless of any changes in their organizational structures. The succeeding agencies shall automatically be substituted and obligated under and by virtue of this MOA.

This MOA shall take effect upon the signing thereof and shall continue to remain in full force and effect until full completion of the project.

## ARTICLE VII AMMENDMENTS, MODIFICATION, AND/OR VARIATIONS

No amendments and/or modifications to this MOA shall be valid or binding unless expressed in writing and executed with the same formality as this MOA:

Variations in the details and/or scope of creative or technical work may be effected only upon written consent of **PDIC**.
