DELIVERY</p> <p>The delivery of the Vehicle shall be made within 15 calendar days upon receipt of this P.O. at the PDIC Head Office located at 6782 SSS Makati Building, Ayala Avenue corner V.A. Rufino Street, Makati City.</p> <p>2. PAYMENT SCHEDULE</p> <p>Payment shall be made not later than seven (7) working days after the issuance of Certificate of Completion and Acceptance by PDIC.</p> <p>3. REPRESENTATIONS AND WARRANTIES</p> <p>The Supplier represents and warrants to PDIC that:</p> <p>It is a domestic corporation duly registered and existing under and by virtue of the laws of the Republic of the Philippines.</p> <p>It has full legal power, authority and right to carry on its present business. The Supplier further warrants that its representative Simeona R. De Guzman – Executive Vice President and/or Marco o. Abellera – Group Sales Manager has full legal power to sign this P.O. and that it will comply, perform and observe the terms and conditions hereof.</p> <p>All corporate and other actions necessary to validate or authorize the execution of this P.O. have been taken.</p> <p>This P.O., when executed and signed, will be legal, valid and enforceable in accordance with its terms.</p> <p>It warrants the Vehicle against any hidden defect which would render it unfit for the use for which it was intended, or which would diminish the fitness of its use to the extent that, had PDIC been aware thereof, it would not have required the said item.</p>		

4. PERFORMANCE SECURITY

To guarantee the full and faithful performance of the obligations required under this P.O., the **Supplier** shall, upon receipt of this Purchase Order, post in favor of **PDIC** a Performance Security in any of the following form:

d) Any combination of the foregoing	Proportionate to share of Form with respect to total amount of security

In the event that the performance security offered by the **Supplier** would be deemed inadequate or otherwise rendered unacceptable, **PDIC** shall have the right to require the **Supplier** to post a performance security in the form and amount determined by **PDIC** and allowed under existing laws and regulation.

The Performance Security shall be released seven (7) calendar days from the issuance of **PDIC's** certification of the **Supplier's** faithful and complete performance of its obligation under this P.O. The Performance Security shall answer any damage that **PDIC** may suffer by reason of the **Supplier's** default of its obligations and/or breach of the terms and conditions of this P.O. It shall likewise guarantee payment for any loss, damage or injury that may be caused by the **Supplier** to **PDIC**.

The Performance Security shall be forfeited in favor of **PDIC** in the event that the **Supplier** is in default or breach of its obligation under this P.O. Any changes made in this P.O. shall in no way annul, release or affect the liability of the **Supplier** and the surety.

Failure of the **Supplier** to comply with any of the terms and conditions of this P.O. order shall result in the forfeiture of the Performance Security.

5. WARRANTY

5. WARRANTY

To ensure that the manufacturing defects shall be corrected/repaired by the **Supplier** as well as compliance by the latter with the terms of this P.O., a retention money or a special bank guarantee equivalent to at least ten percent (10%) of the total purchase price shall be retained/submitted by the **Supplier** in favor of **PDIC** before the latter issues a certificate of acceptance in favor of the **Supplier**. Such amount shall only be released after the lapse of the warranty period as above stated (i.e., 3 years or 100,00 km whichever comes first), provided that the Vehicles purchased and delivered are free from any defects and all the conditions imposed under this P.O. are fully met.

6. LIQUIDATED DAMAGES

In the event that the **Supplier** fails to satisfactorily deliver the Vehicles within the specified delivery schedule, or satisfactorily complete the necessary correction/repair required of the vehicle on any defect within seven (7) calendar days from the time it was reported by **PDIC**, inclusive of duly granted time extensions as approved by **PDIC**, if any, or comply with any of the terms of this P.O., the **Supplier** shall, in addition to other remedies that the **PDIC** may exercise under the provisions of this P.O., pertinent laws, rules and regulations, be liable for damages for the delay and shall pay **PDIC** liquidated damages in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed vehicle scheduled for delivery/correction/repair for every day of delay until such vehicle are fully delivered/corrected/repared and accepted by **PDIC**. **PDIC** need not prove that it has incurred actual damages to be entitled to liquidated damages. Further, **PDIC**, in addition to other remedies that it may exercise under the provisions of this P.O., pertinent laws, rules and regulations, may be allowed to deduct the amount of liquidated damages from any money due or which may become due to the **Supplier**, or collect the same from any securities or warranties posted by the **Supplier** whichever is convenient to **PDIC**. In the event that the total sums of liquidated damages exceed fifteen percent (15%) of the total purchase price, **PDIC** may terminate this P.O. and impose appropriate sanctions over and above the liquidated damages to be paid.

7. NON-WAIVER OF RIGHTS

The failure of **PDIC** to insist upon the strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any right or remedy that **PDIC** may have nor shall it be construed as a waiver of any subsequent breach of default of the terms, conditions and covenants hereof, which in turn, shall continue to be in full force and effect. Non-waiver by **PDIC** of any of its rights under this P.O. shall be deemed to have been made unless expressed in writing and signed by **PDIC**.

8. ADDITIONAL TERMS AND CONDITIONS

If any one or more provisions of this P.O. shall, for any reason, be held void or unenforceable, the legality and enforceability of the remaining provisions contained herein shall not in any way be affected nor impaired, and shall remain in full force and effect.
