## Creditors of Rural Bank of Galimuyod (Ilocos Sur), Inc. have until November 22 only to file claims vs. bank's assets

Creditors of the closed Rural Bank of Galimuyod (Ilocos Sur), Inc. have until November 22, 2022 to file their claims against the bank's assets.

The Philippine Deposit Insurance Corporation (PDIC), the Receiver of said closed bank, reiterated that claims filed after said date shall be disallowed. Creditors refer to any individual or entity with a valid claim against the assets of a closed bank and include depositors with uninsured deposits that exceed the maximum deposit insurance coverage (MDIC) of P500,000.

The PDIC said that creditors may file their claims through any of the following:

- 1. Online through e-mail at <a href="mailto:galimuyod-pad@pdic.gov.ph">galimuyod-pad@pdic.gov.ph</a>;
- 2. Through mail addressed to the PDIC Public Assistance Department, Ground Floor, PDIC Chino Bldg., 2228 Chino Roces Avenue, Makati City 1231. Claims filed by mail must have a postmark date no later than November 22, 2022; or
- 3. Personal filing at the PDIC Public Assistance Center located on the 3rd Floor, SSS Bldg., 6782 Ayala Avenue corner V.A. Rufino St., Makati City, Monday to Friday, 8:00 AM to 5:00 PM. For visits to the PAC, clients are highly encouraged to request an appointment, observe health protocols and present their vaccination cards. Appointments may be requested through the Public Assistance Hotline at (02) 8841-4141 or at the Toll-Free number 1-800-1-888-7342 or 1-800-1-888-PDIC, by sending an e-mail request to <a href="mailto:galilmuyod-pad@pdic.gov.ph">galilmuyod-pad@pdic.gov.ph</a>, or by sending a request through private message at PDIC's official Facebook page at <a href="https://www.facebook.com/OfficialPDIC">www.facebook.com/OfficialPDIC</a>.

The prescribed Claim Form against the assets of the closed bank may be downloaded from the PDIC website, <a href="http://www.pdic.gov.ph/files/Claim">http://www.pdic.gov.ph/files/Claim</a> Form Against Assets of Closed Banks.pdf. PDIC reminds creditors to transact only with authorized PDIC personnel.

Claims filed after November 22, 2022 shall be disallowed. PDIC, as Receiver, shall notify creditors of denial of claims through mail. Claims denied or disallowed by the PDIC may be

filed with the liquidation court within 60 days from receipt of final notice of denial of claim or within 20 days from date of publication of the Order setting the Petition for Assistance in the Liquidation Proceeding for initial hearing, whichever is later.

In addition, PDIC said that depositors with account balances of more than the MDIC of P500,000 who have already filed claims for the insured portion of their deposits as of November 22, 2022 are deemed to have filed their claims for the uninsured portion or the amount in excess of the MDIC.

PDIC, as Receiver of closed banks, requires personal data from creditors to be able to process their claims and protects these data in compliance with the Data Privacy Act of 2012.

Rural Bank of Galimuyod (Ilocos Sur), Inc. was ordered closed by virtue of Monetary Board Resolution No. 1312.B dated September 8, 2022. It is a single-unit rural bank located in Brgy. Poblacion, Galimuyod, Ilocos Sur.

The **Philippine Deposit Insurance Corporation** (PDIC) was established on June 22, 1963, by Republic Act No. 3591 to provide depositor protection and help maintain stability in the financial system by providing deposit insurance. Effective June 1, 2009, the maximum deposit insurance coverage is \$\text{P}500,000\$ per depositor. All deposit accounts of a depositor in a closed bank maintained in the same right and capacity shall be added together. A joint account shall be insured separately from any individually-owned deposit account.
