## Creditors of Rural Bank of Datu Paglas, Inc. have until December 20, 2021, only to file claims vs. bank's assets

Creditors of the closed Rural Bank of Datu Paglas, Inc. have until December 20, 2021, to file their claims against the bank's assets.

The Philippine Deposit Insurance Corporation (PDIC), the Receiver of said closed bank, reiterated that claims filed after said date shall be disallowed. Creditors refer to any individual or entity with a valid claim against the assets of a closed bank and include depositors with uninsured deposits that exceed the maximum deposit insurance coverage (MDIC) of P500,000.

The PDIC said that creditors may file their claims through any of the following:

- 1. Online through e-mail at <a href="mailto:datupaglas-pad@pdic.gov.ph">datupaglas-pad@pdic.gov.ph</a>;
- 2. Through mail addressed to the PDIC Public Assistance Department, 3rd Floor, SSS Bldg., 6782 Ayala Avenue corner V.A. Rufino St., Makati City 1226. Claims filed by mail must have a postmark dated not later than December 20, 2021; or
- 3. Personal filing on an appointment basis only at the PDIC Public Assistance Center located at the 3rd Floor, SSS Bldg., 6782 Ayala Avenue corner V.A. Rufino St., Makati City, Monday to Friday, 8:00 AM to 5:00 PM. Appointments may be requested through the Public Assistance Hotline at (02) 8841-4141 or at Toll Free number 1-800-1-888-7342 or 1-800-1-888-PDIC, by sending an e-mail request to <a href="mailto:datupaglas-pad@pdic.gov.ph">datupaglas-pad@pdic.gov.ph</a>, or by sending a request through private message at PDIC's official Facebook page at <a href="mailto:www.facebook.com/OfficialPDIC">www.facebook.com/OfficialPDIC</a>.

The prescribed Claim Form against the assets of the closed bank may be downloaded from the PDIC website, <a href="http://www.pdic.gov.ph/files/Claim Form Against Assets of Closed Banks.p">http://www.pdic.gov.ph/files/Claim Form Against Assets of Closed Banks.p</a> df. PDIC reminds creditors to transact only with authorized PDIC personnel.

Claims filed after December 20, 2021, shall be disallowed. PDIC, as Receiver, shall notify creditors of denial of claims through mail. Claims denied or disallowed by the PDIC may be filed with the liquidation court within 60 days from receipt of final notice of denial of claim or within 20 days from date of publication of the Order setting the Petition for Assistance in the Liquidation Proceeding for initial hearing, whichever is later.

In addition, PDIC said that depositors with account balances of more than the maximum deposit insurance coverage (MDIC) of P500,000 who have already filed claims for the insured portion of their deposits as of December 20, 2021, are deemed to have filed their claims for the uninsured portion or the amount in excess of the MDIC.

PDIC, as Receiver of closed banks, requires personal data from creditors to be able to process their claims and protects these data in compliance with the Data Privacy Act of 2012.

Rural Bank of Datu Paglas, Inc. was ordered closed by the Monetary Board (MB) of the Bangko Sentral ng Pilipinas on August 26, 2021, and PDIC, as the designated Receiver, was directed by the MB to proceed with the takeover and liquidation of the closed bank in accordance with Section 12(a) of Republic Act No. 3591, as amended. It is a single-unit rural bank located in Poblacion, Datu Paglas, Maguindanao.

The Philippine Deposit Insurance Corporation (PDIC) was established on June 22, 1963 by Republic Act 3591 to provide depositor protection and help maintain stability in the financial system by providing deposit insurance. Effective June 1, 2009, the maximum deposit insurance coverage is P500,000 per depositor. All deposit accounts by a depositor in a closed bank maintained in the same right and capacity shall be added together. A joint account shall be insured separately from any individually-owned deposit account.
